

Notes:

Beginning with the FY 2018 NOFA HUD permitted projects with the same project type to submit an application to consolidate up to four projects into a single application. With that approach, HUD would first approve each individual renewal project application resulting in a consolidated project. The projects listed above followed by an asterisk and a number indicate HUD-approved consolidations from the 2018 NOFA Competition. The notes below show projects approved by HUD for consolidation, and the projects that resulted from the consolidations.

- EDEN, Inc. consolidated Permanent Housing for Persons with Chemical Dependencies 2001, Duplex Scattered Site and Gurnick Place, resulting in a project named EDEN Community-Based Units. FY 2019 renewal name is 19 TRA.
- EDEN, Inc. consolidated Permanent Housing for Persons With Chemical Dependencies 2004 and S+C TRA 2010 creating Permanent Housing for People with Disabilities. FY 2019 renewal name is EC/Lib TRA.
- EDEN, Inc. consolidated Buckeye Long-Term Rental Assistance and S+C SRA 2007 into SRA 2007 Consolidation. FY 2019 renewal is named 14 SRA.
- West Side Catholic Center consolidated RRH 20 and RRH 32 resulting in WSCC RRH 52.

For the 2019 application, FrontLine Service is requesting to consolidate Permanent Housing for Young Adults and Payne Avenue Plus.

Projects applying for funding for the first time through either reallocated or Bonus dollars are bolded.
